## **Essential Caregiver / Compassionate Care Visitation**

Pursuant to NJ Department of Health Executive Directive No. 20-026, Pine Acres recognize the fact that family members and outside caregivers play a vital role in the care and support of residents. As such, we will be permitting necessary essential caregiver / compassionate care visitation to look after the emotional well-being and aid with the care of individual residents while keeping resident and staff safety as our highest priority.

As of June 24, 2020, Pine Acres has established a visitation program to promote the mental health and well-being of our residents while still making sure that we abide by the State Department of Health and CDC guidelines to keep their safety as our top priority

1. We are opening limited 15-minute visitation slots:
  - a. every Monday and Wednesday between 1:00pm and 2:45pm
2. A party must consist of no more than (2) persons.
3. The visitation must be scheduled in advance by calling (973) 377-2124 or e-mailing at [activities@pineacresrehab.com](mailto:activities@pineacresrehab.com). Visitation can only be scheduled from Mondays to Friday from 10:00am to 3:00pm. This gives us ample time to brief visitors regarding the facility's protocols.
4. At the designated visiting time,
  - a. The visitors' temperature will be taken and each visitor will be asked to sign a consent form. You will be then ushered to the designated visiting area.
  - b. The resident will be positioned at the patio, no less than 6-feet away and will be accompanied by a staff member.

- c. Both parties must be masked at all times.
5. For all new residents/patients, visitation can be scheduled 14 days after their admission date.
6. For visitors coming from states included in the NJ travel advisory list, your visitation can only be scheduled after the completion of a 14-day quarantine period upon your arrival to New Jersey.

7. Rights to visit may be revoked at any time should the authorized visitor fail to comply with the necessary guidelines.
